College Credit Management

After you select a Course and Course Sections, in the grid that displays, the Check All column header has been renamed Select All. (StudentInformation Ad Hoc Updates Guide)

CTE Industry Credential

- (E15439) From FY20 and forward, you can now add records for the following industry credential assessments:
 - CH26 National Healthcare Association (NHA) Certified Patient Care Technician (CPCT)
 - CJ35 Ohio State Dental Board Dental Assistance Radiographer's Certificate

Graduation Points

 (E15440,15439) For FY20 and forward, there are 3 new valid Industry Credential Assessment codes available for students who are following the requirements on the 2018+ Requirements tab or the Permanent Requirements tab.

 - The **State Assessment** section tracks the student's progress toward taking the 6 required end-of-course exams: Algebra, Geometry, English Language Arts II, Biology, American Government, and American History. *(StudentInformation Graduation Points Guide)*
 - The **College Admission** section tracks whether the student has met the remediation-free score requirements for the SAT and ACT. (*StudentInformation Graduation Points Guide*)
 - The **Show Competency** section tracks the student's progress toward showing competency in foundational areas of English language arts and mathematics or through alternative demonstrations, including career-focused activities or military enlistment. (*StudentInformation Graduation Points Guide*)
 - The **Show Readiness** section tracks the student's progress toward earning at least 2 diploma seals, one of which must be state defined. (*StudentInformation Graduation Points Guide*)

Notifications

- When an administrator imports assessment data into DataMap, users with access to students whose data is included in the import can now receive notifications for the new Assessment Available rule depending on their district, building, and individual settings. SIS Student Search

- (E15025) When you have a non-public district or school in context, on the Field Selection tab Students subtab, you can now select the new Non-Public SSID checkbox. (StudentInformation EZ Query Guide)
- (E15037) On the Field Selection tab EMIS subtab, in the FN-Graduate accordion list, the new Is Grad Only, Grad Only-Courses Completed IRN, Grad Only-Courses Completed Date, and Proficient Foreign Language checkboxes are now available.

EMIS Extract Import

 (E14940) On the SpecialServices EMIS Extract screen and Special Education Import (SpS) screen, when you process or import files with records that contain matching Disability Condition and Section 504 Plan values that already exist on the corresponding student FD record and have a later IEP or ETR date than the Effective Date on the FD record, you no longer receive the error message "Error! Record has same disability condition and section 504 plan but different effective date as an existing record." The matching record in the import file is not imported.

Standard Reports

Once you receive the results file back from the vendor, you can now select OCTCA FY20 Only from the Assessment Type drop-down list to import OCTCA GY Industry Assessment results into StudentInformation. Student Reporting - Collection (S)

 (E15317) Due to new ODE requirements, the Transfer - Organization - General Information (DN) process no longer includes the attribute that corresponds to the Calendar Type selection on the District and Building Information screen District Organization Info (DN) tab. This attribute is still included in the Transfer - Building and Grade Calendar (DN/DL) process for Calendar Reporting - Collection (C).

StudentInformation

Course Fees

 (D13964) Previously, in schools with course fee waivers enabled, when a student had more than one FD record and a Free/Reduced Lunch status of Free or Reduced, when you added the student to a course with fees, you received an error. Now, in these circumstances, you can add these students to the course without error.

Course Sections

 (D15385) Previously, when you edited a course section EMIS Override tab and updated the value of any field without entering an EMIS Location IRN or EMIS Location Description, an error occurred, incorrectly indicating that the EMIS Location Description is required. Now, the EMIS Location Description is required only when an EMIS Location IRN value of 999999 has been entered.

District and Building Information

(D15429) Previously, on the District Organization Info (DN) tab, when you entered 0 (zero) for any of the fields on the Student Group section and/or College Credit Plus Student Denied Participation/Student Billed section, the valid value was not retained. Now in these circumstances, 0 is saved correctly.

JVS Integration

 (D15388) Previously, when you ran the JVS Integration process, when a student was withdrawn and their course section assignment was dropped at the home school satellite building, the course section assignment stop date was not updated in the JVS clone building. Now, in these circumstances, at the JVS clone building, the course section assignment stop date is updated correctly and the student's demographic record remains the same.

School Year Initialization

 (D15270) Previously, the Attendance: Absence Events task did not copy up the medical designation for absence types with an Absence Group of Medical. Now, the task copies up the medical designation as expected.

Note: If your district already ran SYI prior to the installation of ProgressBook Suite v20.0.0, it is recommended that you manually correct the medical absence types to have an **Absence Group** of **Medical**.

Student Course History Summary

• (D15339,15376) Previously, when a building had multiple schedule results that each resulted in a particular course being assigned to a student, duplicate course history records displayed for that student. Now, in these circumstances, only records from the finalized schedule display for the student.

(D15339) Previously, when a student had a College Credit Plus (CCP) or non-CCP course that was removed or dropped and then reassigned, duplicate records for these courses displayed on the Student Course History Summary screen. Now, in these circumstances, only the assigned course record displays.

Students Needing Adjustments

(D10231) Previously, when you selected a student from the grid to view the **Student Open Fees** screen, the student-in-context feature did not function as expected when you did not have a student in context prior to the selection or when you already had a different student in context. Now, the student-in-context feature functions as expected when you select a student on this screen.

Transcript Formatter (R702)

- (D15323) Previously, the Total Credits subreport on the transcript formatter did not take into account the new CCP Location IRN value on the Marks tab for the course. Now, the subreport displays courses in the appropriate sections of the transcript based on the precedence of the following field values:
 - a. Course Sections screen EMIS Override tab EMIS Location IRN value
 - b. Courses screen Marks tab CCP Location IRN value
 - c. Courses screen EMIS tab EMIS Location IRN value

• (D15017) Previously, when an ESC imported a **PS ELA** assessment file, all students displayed on the **Unmatched** tab after getting incorrectly matched on **School IRN** instead of **District IRN**. Now, the import correctly matches students based on their district IRN.

SpecialServices EMIS Extract

 (D15420) Previously, when you created an EMIS extract, missing or invalid dates for FD, FE, GE, and GQ records were incorrectly identified only as missing dates in the associated error log file. Now, the error message in the associated error log file has been updated to indicate that these dates are missing or invalid (e.g., "Missing or invalid Start Date for IIEP").

Identity Management

- All references to user records have been updated to account records (e.g., the View Users screen has been renamed View Accounts). The new user record screen (see "User record") contains all information for a user (person), including both account and staff member records. (StudentInformation Security Guide)
- Users (i.e., personnel) must now have accounts in StudentInformation to log in to ProgressBook applications. You can no longer manage accounts, and therefore user login access, in CentralAdmin or GradeBook. (*StudentInformation Security Guide*)

Note: You can still manage CentralAdmin access for accounts in CentralAdmin.

User record

- The new user record screen lets you add, modify, and associate account and staff member records. This screen displays when you add an account or staff member record on the **View Accounts** screen or **View Staff Members** screen, respectively.
- The **Personal** tab lets you view and modify shared information from both account and staff member records.
- The **Account** tab lets you:
 - view and modify the user's account record
 - view and modify assigned roles
 - view and modify assigned groups
 - view and modify assigned staff member impersonations
 - reset the account password
- The Staff tab lets you view and modify the user's staff member record as well as add staff member school(s) and job function(s).
 - The permissions granted in GradeBook by the deprecated GradeBook user roles have been incorporated into the existing StudentInformation job functions as listed below:

- The following user roles from GradeBook have been added to StudentInformation as job functions:

- The new **GradeBook Principal** and **GradeBook Guidance** job functions let you assign the GradeBook-specific permissions separately from the **Principal** and **Counselor** job functions, which grant specific permissions for both StudentInformation and GradeBook.
- On this screen, you can also create new account or staff member records and associate them with each other.

View Accounts

- On the View Accounts screen, in the search results grid, the Central Links and Central Info columns have been replaced by the Account Type column. The search results no longer return vendor account records. The Go button has been renamed New Account.
- When you click **New Account**, a new window opens, prompting you to enter required information.
 - If there are no existing matching staff member records, the user record screen **Account** tab displays for the newly created account.
 - If an account with a matching first and last name and/or email address exists, you can choose to edit the account by clicking **Edit Existing Account**. The user record screen **Account** tab displays for the matching account.
 - If a staff member record with a matching first and last name and/or email address exists, you can choose to associate the new account with the existing staff member record. Otherwise, you can click **Create Unassociated Account**. In either situation, the new user record screen **Account** tab displays for the newly created account.

View Groups

 On the View Groups screen, when you add or edit a group, on the Group Members tab, you can now click a link in the Last/Group name column to navigate to the user record screen for that user or the vendor maintenance screen for the vendor. (StudentInformation Security Guide)

- (D15461) Previously, the Industry Credential assessment codes **CJ93** and **CJ94** displayed for the **Construction**, **Engineering**, and **Manufacturing** areas, but did not display for **Agriculture** as expected. Now, in this circumstance, the **CJ93** and **CJ94** assessment codes correctly display for **Agriculture**.
- (D15169) Previously, when a student had a special education **Grad Requirement** record that met all of the following conditions, the student incorrectly received end-of-course exam exemption credit toward their graduation progress for the selected subject area:
 - IEP Date value fell outside of the current school year
 - End-of-course Assessment Area value was selected
 - Exemption Flag was set to "Y"
 - Student took the test for the selected Assessment Area at least once

Now, only special education end-of-course exam subject exemption records with **IEP Date** values that fall within the current school year count toward a student's graduation progress. (*StudentInformation Graduation Points Guide*)

Student Fee Assignment

(D15372) Previously, when configuring the Student Fee Assignment process, when you selected the Membership Fees checkbox and the Reset Fees - Remove fee assignments and don't create new assignments option on the Assignments tab, and then selected to remove only specific membership fees on the Options tab, all membership fees were removed from students who met the search criteria regardless of the selected memberships on the Options tab. Now, in these circumstances, the fees of only the selected memberships on the Options tab are removed from the students who meet the search criteria.

View Pending Students

(D15360) Previously, when a student transferred back into a district in which they were
previously enrolled and you bulk enrolled pending students, after you completed the bulk
registration process, the County of Residence field was blank on the newly created FS
records for that student. Now, in this circumstance, the County of Residence field for the
student populates as expected from the sending district.

Student Graduate CORE Summary Maintenance

 (D10777) Previously, when you added a record, although the **Dual Credit** field was not required, when you tried to save with a blank **Dual Credit** value, an error occurred. Now, the **Dual Credit** field defaults to 0.00 when you leave it blank and you can save without error.
