Student Reporting - Collection (S)

- Due to new requirements from ODE, when you run the **Transfer - Organization - General Information (DN)** process, the file no longer contains attribute records for **C_CLDRTYPE**. All prior attribute records of **C_CLDRTYPE** have been deleted.

Resolved Issues

Course Section Assignments

- (PBSIS-1087) Previously, when you searched for course groups for a specific schedule, duplicate course sections from the same course group displayed. Now, in these circumstances, each course section in the course group displays only once.

Course Section Mark Entry

- (PBSIS-9658) Previously, courses with a **Course Type** of **OL - Online** did not display. Now, they display as expected.

Edit Student Profile


- (PBSIS-2270) Previously, on the **Custom** tab, when you had a miscellaneous data definition with a **Data Type** of **Time** and a value in the field, when you tried to navigate away from the tab without changing the value, you were prompted to save. Now, in this circumstance, the save prompt does not display.
- (PBSIS-9332) Previously, on the **FD-Attributes** tab, the FD grid column header incorrectly listed **LEP**. Now, the column header is **EL**. ([StudentInformation Student and Registration Guide](#))

EZ Query SIS Student Search

- (PBSIS-9103) Previously, the **Filter Criteria** tab **EMIS** subtab incorrectly displayed **Limited English Proficiency** instead of **English Learner**. Now, **English Learner** displays.

- (PBSIS-9102) Previously, on the **Field Selection** tab **EMIS** subtab **FD-Attributes** accordion list, when you selected the **English Learner** checkbox, students who met the criteria were included in the output file but the corresponding column in the file was blank. Now, in this circumstance, the output file contains the appropriate value for each student in the **English Learner** column.

Family Groups

- (PBSIS-7988) Previously, when a family group no longer had students assigned to it and you clicked  to delete it, nothing happened. Now, when there are no students assigned to a family group, it no longer displays.

Specified Marks by Teacher (R302B)

- (PBSIS-3127) Previously, when a student was assigned more than one course to the same teacher, the following errors occurred in the report:
 - Marks and records for one of the courses did not display
 - Student appears to be assigned a different course with the same teacher with no marks

Now, in this circumstance, the report includes both courses to which the student is assigned as well as their corresponding marks.

Student Marks

- (PBSIS-10292) With the release of ProgressBook Suite v20.4.0, courses with a **Course Type** of **OL - Online** did not display. Now, they display as expected.

Students Scheduled With Free Time (R415A)

- (PBSIS-8727) With the release of ProgressBook Suite v20.3.2, when you entered a value for the **Minimum Free Periods in a Schedule Term for Student to Appear On Report** field, students who met the criteria were incorrectly omitted from the generated report. Now, when students have periods with free time that are equal to or greater than the value entered for that field, they are included in the report.

Students Scheduled With Free Time By Period (R415B)

- (PBSIS-8727) With the release of ProgressBook Suite v20.3.2, when you entered a value for the **Minimum Free Periods in a Schedule Term for Student to Appear On Report** field, students who met the criteria were incorrectly omitted from the generated report. Now, when students have periods with free time that are equal to or greater than the value entered for that field, they are included in the report.

Teacher Course List

- (PBSIS-9658) Previously, courses with a **Course Type** of **OL - Online** did not display. Now, they display as expected.

StateReporting

ACT

- (PBSIS-9347,9357) Previously, when you tried to edit an ACT FY21 record that was imported, an error occurred. Now, you can edit such records successfully.

Note: A script has been included in the ProgressBook Suite v21.0.0 release to update all existing imported records to resolve this issue.

Assessment Imports

- (PBSIS-9190) Previously, when you ran the **ACT FY21+** import option, when the import file **Test_Dtr** (column AO) value only had 5 numbers without the leading 0, records were not created for such records. Now, in this circumstance, these records are imported successfully.

Assessment Reporting - Collection (A)

- (PBSIS-11291) Previously, when you ran the Transfer - CTE Student Assessment - OCTCA (GY) process, students who did not have a graduation date were incorrectly excluded from the transfer file. Now, in this circumstance, all students who have OCTCA records are included.

Staff/Course Reporting - Collection (L)

- (PBSIS-8883) Previously, when a student was assigned more than one course section for the same course code and dropped one of the course sections prior to course completion, when you ran the **Verify/Update - Course and Class List (CLISEMIS/CTRMEMIS)** process, the student incorrectly received credit for the dropped course section. Now, in this circumstance, the student does not receive credit for the dropped course section.

Student Reporting - Collection (S)

- (PBSIS-10952) Previously, when you ran the **Verify/Update - Non-graduate CORE Summary** process and received the error **GC13E - No Dual Credit value entered for this Manually Entered course for this student**, and then clicked the school year link in the **Course Code** column to resolve the issue, an error occurred and users could no longer access the **College Credit Management** screen. Now, in this circumstance, when you click the link, you are taken to the corresponding course screen and no access is lost to the **College Credit Management** screen.
- (PBSIS-10952) Previously, when you ran the **Verify/Update - Non-graduate CORE Summary** process, you incorrectly received errors for courses with dual credit for future school years. Now, in this circumstance, these courses are not included in the process.

Now, in this circumstance, no duplicate student statuses display.

Family Groups Wizard

- (PBSIS-5526) Previously, on the **General** tab, when you selected the **Remove existing groups in the district** checkbox, the following message incorrectly still displayed: **Any Parent Access Accounts associated with the Family Groups will be deleted.** With the release of ProgressBook Suite v16.1.0, ParentAccess accounts are no longer associated with family groups and the accounts are no longer deleted when family groups are deleted. Now, in this circumstance, the message no longer displays.

Graduation Points

- (PBSIS-4618) Previously, when a student had a **Fiscal Year Began 9th** value of **2018**, administrators were incorrectly able to view the **2018+ Requirements** tab and **2018+ Optional Pathways** tab on the **Grad Points Summary** screen for that student. Now, these 2 tabs display only for students who have a **Fiscal Year Began 9th** value of **2015**, **2016**, or **2017**.

Identity Management

- (PBSIS-10088) Previously, when you assigned the **Master** job function to an account, the user incorrectly displayed in **Teacher** drop-down lists throughout the application. Now, in this circumstance, the **Teacher** drop-down lists display only users with the **Teacher** job function.

- (PBSIS-7219) Previously, when you tried to edit a marking pattern mapping, an error occurred. Now, you can successfully edit marking pattern mappings.

Student Schedule

- (PBSIS-12417) Previously, when you ran the **Scheduler** for a single student on the **Requests & Assignments** screen, the new assignments were not aligning with the corresponding requests. Now, in this circumstance, assignments and requests are aligning as expected.

Now, in this circumstance, only records with marks from courses that have active marking patterns are included.

- (PBSIS-7596) Previously, when you ran the **Verify/Update - Non-graduate CORE Summary** process and selected only some of the buildings, when a student had earned credit for a manually entered course within a building that was not selected, you received a GC11E error indicating that the manually entered course has no earned credits. Now, in this circumstance, the process runs successfully without error.

 - **Expected Graduation Date**

Student Reporting Collection (S)

- When transferring the **Student Special Education (GE)** records for continuously enrolled students, the transfer file will only include events from 7/1 through 6/30 of the current school year. For students newly enrolled at the district, the transfer file will continue to include prior year records as well as the current school year records.
- When transferring the **Student Program (GQ)** records to the **Data Collector**, the **Graduation Seals** for **Plans to Earn** and **Earned** are included in the transfer file based on the selections in **Graduation Points > Student Exemptions/Requirements** in the **State System of Diploma Seals** section.

Note: An exception to this rule is the **Program Codes** for the **Earned Seal of Biliteracy**. The **Language codes** for the **Seal of Biliteracy** need to be added to the student's **Membership Records** to be included in the **GQ** transfer file.

- If the **Plans to Earn** checkbox is selected for the seal, the **Plans to Earn Program Code** is included.
- If the **Earned** checkbox is selected for the seal, the **Earned Program** is included, with the exception of seals that do not report an **Earned Program Code** and only report a **Plans to Earn Program Code**.
- If both the **Plans to Earn** and **Earned** checkboxes are selected for the seal, then the **Earned Program Code** is reported, unless it is a seal that does not report the **Earned Program Code**, in which case the **Plans to Earn Code** is reported.

Graduate Reporting Period (G)

- On the **EMIS - Verify/Update and Transfer Period (G)** screen if you have selected to transfer **EMIS Data (G)** records, and then selected **Transfer - Student Program (GQ)** on the **Program Selection** tab, the file now includes a program record for **Graduation Seals** that the student either plans to earn or has earned if the student meets the following criteria:
 - The Student has a Graduation Date saved on the FN Graduate tab.
 - The Student has a Diploma Type other than * on the FN Graduate tab.

The Program Record reported depends on the selections in **Graduation Points > Student Exemptions/Requirements** in the **State System of Diploma Seals** section.

Resolved Issues

Student Information

Calendar Exception Management

- (PBSIS-4313) Previously, when updates were made to a calendar date using the **Calendar Exception Management** or **Calendar Bulk Exception Management** screen, the **Student's School Absences** screen did not honor the change until the date was also edited/saved on the respective sub-calendar. Now, once you update a date using the **Calendar Exception Management** or **Calendar Bulk Exception Management** screens, the student school absence page honors the change.

Daily Absence List

- (PBSIS-15784) Previously, when you viewed **Attendance Statistics** on the **Daily Attendance** tab, the **Absence Type** table and the **Grade Level** table overlapped. Now, these tables do not overlap.

Daily Office-Student Absences (R307)

- (PBSIS-14359) Previously, a timestamp printed on the report cut off the total value for **Total Absences**. Now, the timestamp has been removed to allow room for **Total Absences**.

Grad Points Summary

- (PBSIS-15900) Previously, in the **Show Competency - Additional Options** section, the **Point Value** for the **CP05 – Bleeding Control Basic 1.0 Course** incorrectly displayed 4 points. Now, this course correctly displays 1 point.
- (PBSIS-17490) Previously, in the **Show Competency - Additional Options** section, the **Point Value** for the **CP31 – Business and Finance & Hospitality and Tourism** incorrectly displayed 3 points. Now, this course correctly displays 6 points.
- (PBSIS-15887) Previously, credit totals did not include manually added course history records for the current year. Now, these records are included in credit totals.

Student Exemptions/Requirements

- (PBSIS-16676) Previously, in the **Optional Career-Technical Requirements** section when you updated the selection in the **Pre-Apprentice** checkbox, the corresponding **Pre-apprenticeship (Foundational)** information on the **Permanent Requirements** tab of the **Grad Points Summary** did not update. Now, changes to the **Pre-Apprentice** checkbox on the **Student Exemptions/Requirements** screen are reflected correctly on the **Permanent Requirements** tab of the **Grad Points Summary**.

Student GPA History

- (PBSIS-16166) Previously, the **Honors GPA** calculation was not including attempted credits, so if a student received an F (no earned credits), it did not impact the Honors GPA Calculation. Now, the Honors GPA calculation has been corrected to include attempted credits, and an F impacts the GPA.

Locker Maintenance

- (PBSIS-14212) Previously, the locker assignment for a withdrawing student was not removed if a Reference Location was not set for the locker in **Locker Maintenance**. Now in this scenario, the withdrawing student's locker assignment is removed.

Marks Reports

- (PBSIS-14591) Previously, the **Report Card Formatter (R700)** report printed the District Superintendent's prefix between the first and last name. Now, the prefix prints before the first name.
- (PBSIS-16747) Previously, the **Report Card Formatter (R700)** report generated an error if any of the following formats was selected: **FixedH1**, **FixedL1**, **FixedL2**, or **FixedN3**. Now, this has been corrected.
- (PBSIS-15756) Previously, if the **Transcript Formatter (R702)** report included the **Seals** subreport, the subreport included seals with **Plans to Earn** selected. Now, when the **Seals** subreport is included in the **Transcript Formatter (R702)** report, only seals that have **Earned** selected are included.

Scheduling

- (PBSIS-14643) Previously, on the **Courses** screen, searching for a course with a 15-character code returned no results. Now, when you search using the 15-character course code, the course is returned.

Student Profile

- (PBSIS-17915) Previously, when using Google Chrome™ web browser, Google autofill populated the **Birthplace City** field with students' **Ethnicity** code. Now, a fix has been put in place to prevent this.

Student Request Specific Course (R404)

- (PBSIS-7339) Previously, students who were missing a phone number on their **Student Profile** were excluded from the generated report. Now, these students are included in the report.

Student Scheduling Analysis Report (R426)

- (PBSIS-15701) Previously, the report produced incorrect results when the **Course Term** filter was used. Now, the **Course Term** filter has been removed since it is not relevant to unscheduled requests.

Students With No Requests or Assignments (NORQ)

- (PBSIS-17747) Updates have been made to improve the performance of this report.

WebService Administration

- (PBSIS-10226) Previously, **WebService Administration** did not list buildings for which the principal had an apostrophe in their name. Now, this has been corrected.

StateReporting

Assessment Imports

- (PBSIS-16139) Previously, the **ACT FY21+** files encountered an issue with the field values for column AA. Now, you can successfully import **ACT FY21+** files.
- (PBSIS-7597) Previously, the **Workkeys Assessment Import Template** did not import assessment values unless Columns **H** and **I** in the import file contained a value. Now, the **Workkeys Assessment Import Template** imports records for any one of the three assessments a student can take that are in the file and skips any blank columns without giving an error.
- (PBSIS-17169) Previously, in **EZ Students>Shared Student Data** for **Assessment** data, **PSA ELA** records did not display correctly for certain buildings if a student attended an ESC or preschool in another district and the **IRN** returned on the vendor results was not an **IRN** in the student's home district. Now, in this scenario, the **Assessment** information displays the records that matched the **IRNs** of both entities being displayed in the search. The **Preschool ELA Import** has been updated to use the **IRN** of the school the student is enrolled in at the time of the test for the imported record instead of importing an **IRN** that does not belong to the student's district. This corrects the display going forward. Prior year records that have already been imported and have **IRNs** outside of either district will still not display.

Import/Export

- (PBSIS-14736) Previously, the **Pre-Identification Export>Pre-Ident For KRA** export included withdrawn students with no active assignments. Now, these students are not included.

Civil Rights Report (CRR)

- (PBSIS-16158) Previously, **CRR SCHR-1 Grades with Students Enrolled** showed "Yes" for a grade level in which students were all enrolled out of the district. Now, "Yes" only displays when the grade level has at least one active/enrolled student with a percent of time greater than 0.
- (PBSIS-16038) Previously, **CRR DISC-1 Preschool Suspensions and Expulsions** was not counting **Out-of-School Suspensions** and displayed "0". Now, Out-of-School Suspensions are counted correctly for **DISC-1**.

- (PBSIS-16630) Previously, the **DIND: COVID-related Directional Indicators (DIND-1 and DIND-2)** selected for a campus on the **Manual Civil Rights Data Entry** screen were not included in the CSV report format for the **Civil Rights Report**. Now, **DIND-1** and **DIND-2** indicators are included in both the CSV and PDF report output formats.
- (PBSIS-16595) Previously, for **RETN-1 Student Retention Indicator** and **RETN-2 Retention of Students**, the system compared the **State Equivalent Grade Level** from the prior year to the year in which the **Civil Rights Report** was being processed. Now, **RETN-1** and **RETN-2** have been updated to include students as retained when the **Civil Rights Report** year grade level equals the **Future School Year** grade level.
- (PBSIS-16030) Previously, **ENRL-2B EL Students in Programs** identified students in programs 235012 or 235013. Now, **ENRL-2B** has been updated to identify students in programs 235023 or 235025.
- (PBSIS-16816) Previously, if a district had a building that was Active for the year in which the **Civil Rights Report** was being processed, but the building had no data, when **DISC-11 Instances of Suspension** was generated for all buildings in the district, the values in the **W/O Disabilities** column and the **With Disabilities 504** column were switched. Now, in this scenario, column values display correctly for **DISC-11**.
- (PBSIS-15828) Previously, **DISC-12 School Days Missed Due to Out-of-School Suspensions** only displayed zeros and did not produce any counts. Now, **DISC-12** has been updated to use the duration value from the discipline action record for the values in this table and data is being pulled correctly for student counts.

Student Reporting Collection (S)

- (PBSIS-11255) Previously, the **EMIS Run Requests (CHECK_EMIS)** screen displayed Majority of Attendance IRN (MAJOREMIS) sections that are no longer used as Required items. Now, the **EMIS Run Requests (CHECK_EMIS)** screen only shows the following items as Required for MAJOREMIS:
 - **Student Collection Verify - MAJOREMIS Verify**
 - **Student Collection Update – MAJOREMIS Update**
